Town Administrator: This past week's activities included continued research and work on documents for transfer of Town property at 4 Whittier Highway, prepared for and attended the Select Board's weekly meeting, continued preparations for the proposed FY 17 operating and capital budgets and Town Meeting warrant public hearing, met with Planning Board chair, vice chair, Selectman Russ Wakefield and interim Town Planner to review several ongoing activities, met with the Town Engineer, DPW Director and two petitioners of the sidewalk project warrant article of 2015 to review the project plans to date, and attended the monthly Lakes Region Managers' meeting. This week I will continue work on revisions to the employee evaluation form and process, complete my presentation for the FY17 budget hearing on Thursday, prepare ads for the Town Assessor's position, conduct the monthly Department Head meeting, prepare for the Select Board's meeting on Thursday at 7 p.m. and meet with Superintendent Noyes. Public Works & Facilities: Last week the Highway crews continued to perform routine winter fleet maintenance both prior to and after the storm event. With more salt and sand deliveries, the crews continued to make the "magic mix" and also restock the sand/salt shed.

Transfer Station: This week Our Town Bio Diesel picked up 55 gallons of waste cooking oil that will be turned in to bio-diesel (55 gallons that was diverted from the land fill and repurposed). We shipped 1 msw container and 1 single stream container.

Moultonborough Police Department: The Police Department recorded 329 log entries, which included the following calls for service, 21 motor vehicle stops, 4 assists to Fire/EMS, 1 Directed Patrol, 2 arrests, 9 complaints, 6 MV Accidents, 6 MV Complaints, 5 residential alarms, 1 commercial alarm and 0 K-9 complaints.

Training: Jan. 30th thru Feb. 3rd, Sgt. Beede and Sgt. Boucher attended FBI LEEDA training.

Moultonborough Fire Department: Year to date 66 calls for emergency service. For the period of 01/27/17 to 02/02/17, there were 10 calls for service: (4) EMS incidents; (2) Motor vehicle accidents, no injuries; (1) Lockout, residential; (1) Unauthorized burning; (1) Carbon monoxide detector activation due to malfunction; (1) Extinguisher system activation. Automatic Aid: Moultonborough received automatic mutual aid twice from Center Harbor.
