Finance: Nothing to report this week.

Assessor: Whitney Consulting Group is continuing the 20% cyclical inspection field work. Their field staff will have an identification badge and a letter from the Town Assessor. Our office is reviewing and updating current use files to ensure they comply with the state RSA's and rules. We are requesting updated maps showing areas in current use and not in current use. We also continue to work on integrating more of our new and existing data into the Avitar assessing database. Tax Collector: Nothing to report this week.

Town Clerk: Nothing to report this week.

Department of Public Works: Highway's week began with doing storm clean-up which included salting, sanding, and plowing of roads throughout town. The crew continued the week doing maintenance on trucks and equipment. The week ended preparing for 2" of rain that was predicted. This included taking care of culverts, catch basins and all drainage concerns throughout town.

Facilities & Grounds: Nothing to report this week.

Transfer Station: Last week we shipped out 2 containers of municipal solid waste, 2 of single stream recycle and 2 of construction and demolition. The brush pile was burned. Car counts for this week Monday 305, Tuesday 507, Friday Christmas Closed, Saturday 544, Sunday 398. Total of 1754 served.

Moultonborough Police Department: The Police Department recorded 172 log entries, which included the following calls for service, 7 Assist Citizens, 11 Motor Vehicle Stops, 7 Assists to Fire/EMS, 0 Directed Patrols, 2 Arrests, 7 complaints, 2 MV Accidents, 3 MV Complaints, 4 Residential Alarms, 0 Commercial Alarms and 0 K-9 complaints.

Moultonborough Fire Rescue: For the period of 12/18/2020 to 12/24/2020, there were 19 calls for service: There was: 1 - Dumpster fire, 9 - EMS calls, 1 - Motor vehicle accident with no injuries, 1 - LP gas leak, 1 - Carbon monoxide incident, 1 - Police matter, 1 - Smoke detector activation, no fire, unintentional, 4 - alarm system activation, no fire, unintentional **Year to Date Incidents:** 918 **Automatic Aid:** received once from Stewart's Ambulance and once given to Sandwich. **Mutual Aid:** None **Overlapping Incidents:** once for this period. Year to date there have been 164 instances of two or more incidents occurring at the same time

Operations: Following nearly two feet of snow, the day shift worked to clear access to dry hydrants around town. The Public Safety Building remains open in a limited capacity. Fire permits, permits to install, and operate oil fired equipment are being issued through a service window installed in the lobby door. The meeting room and public restrooms remain closed during the pandemic due to sanitizing concerns. Residents and businesses having questions life safe and fire code issues may access fire department services through the lobby or by calling 476-5658.

COVID-19 Status Report: The Fire Chief/Emergency Management Director continues to participate in conference calls regarding the ongoing COVID-19 pandemic and the situation in the State. Eighteen firefighters and six police officer are registered with the Winnepesaukee Public Health Region to receive Coronavirus vaccinations as part of the State Vaccination plan for the 1A Group. The Winnepesaukee Public Health District is scheduled to perform the vaccinations in early January. The New Hampshire Department of Health and Human Services COVID-19 Dashboards located at <https://www.nh.gov/covid19> indicate that as of 12/27/2020, Moultonborough currently has 14 positive cases and a cumulative total year to date of 118 cases.

Schools: The Christmas break began Thursday December 24 with school resuming Wednesday January 6, 2021. The current plan is for in-person students to return to in-person school on Wednesday, January 6, 2021. If community spread should warrant a change to that plan the School Board will have a special meeting on January 5, 2021 to discuss the matter. While school is closed there will be no school sports. Sports practices are scheduled to resume on January 6, 2021.

Childcare Centers: No new reports have been received alerting a change in status.

Local Businesses: The NH Attorney General's Office, Emergency Order Compliance Task Force reached out to the Health Officer regarding a complaint about a Whittier Highway establishment with staff not wearing masks. Health Officer Zalewski conducted a visit to the establishment on 12/23, confirmed that masks were not being worn by staff and reported his findings to the AGO

Burning Permits: Snow Cover and Brush Burning. Brush may also be burned at any time without a fire permit when the ground is covered with snow. RES 5601.01 defines snow cover as the following:
"Ground covered with snow" means the area within a 100-foot radius from the fire edge is covered with snow or other frozen precipitation sufficient to prevent the combustion of woodland fuels until the fire is completely extinguished

Land Use Department: Nothing to report this week.
