

## ORDINANCE

### TOWN OF MOULTONBOROUGH, NEW HAMPSHIRE

#### An Ordinance Relative to the Use of Town Beaches

- Section 4.1 Regulated areas:
- a. All of the property at Long Island Beach owned by the Town of Moultonborough on both sides of Long Island Road and at the south end of the Long Island Bridge.
  - b. All of the property at States Landing Beach owned by the Town of Moultonborough adjacent to States Landing Road.
  - c. All of the Town property surrounding Access Road providing access to Lee Pond.
- Section 4.2 Parking for the Moultonborough town beaches shall be permitted for the vehicles of town residents and/or taxpayers in areas designated for such parking, or as otherwise directed by the Selectmen.
- a. Only vehicles displaying a Town Beach Parking Permit shall be allowed to park at the town beaches.
  - b. The Selectmen shall issue a parking permit to all persons who request such permit as follows:
    - 1.) apply in person at the office of the Selectmen;
    - 2.) present evidence of status as resident and/or taxpayer;
    - 3.) present registration card for each vehicle for which a permit is requested;
    - 4.) tender application fee as set from time to time by the Selectmen for each permit requested.
- Section 4.2a Parking is very limited on or near Access Road. There shall be no reserved parking on Access Road or the surrounding Town property. There shall be no overnight parking on Access Road or the surrounding Town property.
- Section 4.3. Town beach parking permits shall be valid for only the vehicle for which they are issued, and only while such vehicle is owned by a resident or taxpayer of the Town of Moultonborough. Permits are not transferable.

All permanent Town beach parking permits shall be affixed to the left side of the vehicle, plainly visible, for each vehicle desired to be parked at a town beach. Seasonal Beach Permits shall be placed on the dash of the vehicle when parked at the Beach facility.

Section 4.4 Residents and taxpayers of the Town of Center Harbor, whose vehicles display a current permit sticker for beach privileges in the Town of Center Harbor shall be entitled to all the parking and beach privileges specified above at the Moultonborough town beaches, so long as the Town of Centre Harbor continues to grant such reciprocity to residents and taxpayers of the Town of Moultonborough.

Section 4.5 The use of certain flotation devices, water toys or similar items is expressly forbidden at both Long Island and States Landing Beaches. The prohibited items include the following.

- a. Air mattresses, rubber rafts or boats;
- b. "Floaties" or water wings;
- c. Swim Bubbles;
- d. Inner tubes;
- e. Inflatable balls or toys; and,
- f. Snorkels.

No exceptions shall occur or be permitted.

Section 4.6 This ordinance is not intended and shall not be construed to be inconsistent with any existing ordinance of the Town of Moultonborough related to the use of town docks, wharfs, and beaches owned and/or controlled by the Town of Moultonborough.

Section 4.7 The Board of Selectmen is hereby empowered to enact such rules and regulations as it deems necessary from time to time to effect the provisions of this ordinance.

Section 4.8 Violation of any of the provisions of this ordinance shall be punishable by a fine of not less than seventy-five dollars (\$75.00), and each day of violation shall constitute a separate offense.
