

ORDINANCE

TOWN OF MOULTONBOROUGH, NEW HAMPSHIRE

An Ordinance Relative to Boat Parking at Town-owned Dock and Launch Ramps

- Section 5.1 This ordinance shall pertain to the permanent docks provided by the Town of Moultonborough at the Lee's Mills Facility. This ordinance shall also pertain to the seasonal docks installed as a user convenience by the Town beside the launch ramps at the Lee's Mills boat launch and the boat launch at Long Island Beach.
- Section 5.2 Public boat parking at the town-owned boat docks will be limited to two-hours. The Town provides three docks for public use. These docks are located southwest of the boat launch ramp at the facility. Use of these docks is described and limited in Sections 4.2a and 5.2b below.
- Section 5.2a The dock closest to the launch ramp along the shoreline serves as docking space for the Town's Fire Boat. One slip (side) of this dock is reserved for that Fire Boat. No public parking may ever occur at the slip on the north east (launch ramp) side of this dock.
- Section 5.2b Parking at the remaining slips (sides) is limited to two hours. Boat parking is available on a "first come, first serve" basis. The Town assumes no liability for boats parked at these slips.
- Section 5.2c. Boat parking at the seasonal docks provided by the Town at the Town's launch ramp sites is for the convenience of users who launch boats there. Use of these docks shall be limited to the time required to launch one's boat, remove one's vehicle from the launch ramp and immediately return to remove one's boat from the dock. Any parking beyond this task represents a violation of this ordinance. Violators may without exception or extenuating circumstance be cited as provided below.
- Section 5.2d. Except as provided above, no public boat parking is allowed in any other area at the Town's Lee's Mills, States Landing and Long Island facilities.
- Section 5.2e. By parking at the Town's docks at any of the Town's facilities, the owner and/or user of a boat, and all members accompanying that individual, agrees to indemnify and hold harmless the Town in all claims, lawsuits and other legal proceedings relating to use of or condition of the Town's facilities.
- Section 5.2f. Reserved

Section 5.3 Violation of any of the provisions of this ordinance shall be punishable by a fine of not less than fifty dollars (\$50.00), and each day of violation shall constitute a separate offense.

Section 5.4 The registered owner of any boat in violation of this ordinance shall be considered the violator.

This ordinance to be in force as of August 23, 1990.
